
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

A. The purpose of this modification is to obligate funds to CLIN 0001 (Department of Energy (DOE)), in accordance with SRNS FINPLAN 21. Funds in the amount of \$2,150,005.61 are hereby obligated to CLIN 0001, thereby increasing it from \$5,679,008,597.17 to \$5,681,158,602.78.

B. As a result of this modification, Part I - Schedule, Section B, Supplies or Services and Price/Cost, paragraph B, entitled "Obligation of Funds," is hereby revised to increase the total amount of funds obligated to the contract from \$7,078,736,941.00 to \$7,080,886,946.61.
