A. The purpose of this modification is to de-obligate funds from CLIN 0001 (Reimbursable Work Commercial (Non-Appropriated Funds)), in accordance with SRNS FINPLAN 22. Funds in the amount of (-\$61,221.69) are hereby de-obligated from CLIN 0001, thereby decreasing it from \$5,685,729,891.38 to \$5,685,668,669.69.

B. As a result of this modification, Part I - Schedule, Section B, Supplies or Services and Price/Cost, paragraph B, entitled "Obligation of Funds," is hereby revised to decrease the total amount of funds obligated to the contract from \$7,085,458,235.21 to \$7,085,397,013.52.

C. The contract estimated value and all other terms and conditions remain unchanged.
