
A. The purpose of this modification is to obligate funds to CLIN 0001, (Department of Energy (DOE)) in accordance with SRNS FINPLAN No. 9 for FY 2015. Funds in the amount of \$51,515,747.67 are hereby obligated to CLIN 0001, thereby increasing it from \$6,232,701,011.97 to \$6,284,216,759.64.

B. As a result of this modification, Part I - Schedule, Section B, Supplies or Services and Price/Cost, paragraph B, entitled "Obligation of Funds," is hereby revised to increase the total amount of funds obligated to the contract from \$7,632,429,355.80 to \$7,683,945,103.47.
