


A. The purpose of this modification is to de-obligate funds from EB2501030 (Legacy B&R), an American Recovery and Reinvestment Act (ARRA) project, in accordance with SRNS Fin Plan No. 10 for FY 2015. Funds in the amount of (-\$3,385.22) are hereby de-obligated from CLIN 0003, thereby decreasing it from \$1,396,053,243.83 to \$1,396,049,858.61.

B. As a result of this modification, Part I - Schedule, Section B, Supplies or Services and Price/Cost, paragraph B, entitled "Obligation of Funds," is hereby revised to decrease the total amount of funds obligated to the contract from \$7,687,158,178.88 to \$7,687,154,793.66.
