A. The purpose of this modification is to de-obligate funds from CLIN 0001, (Department of Energy (DOE)) in accordance with SRNS FINPLAN No. 14 for FY 2015. Funds in the amount of \$3,082,583.80 are hereby de-obligated from CLIN 0001, thereby decreasing it from \$6,510,452,371.68 to \$6,507,369,787.88.

B. As a result of this modification, Part I - Schedule, Section B, Supplies or Services and Price/Cost, paragraph B, entitled "Obligation of Funds," is hereby revised to decrease the total amount of funds obligated to the contract from \$7,910,171,848.54 to \$7,907,089,264.74.
