

A. The purpose of this modification is to obligate funds to CLIN 0001, (Reimbursable Work Commercial (Non-Appropriated Funds) in accordance with SRNS FINPLAN No. 18 for FY 2015. Funds in the amount of \$1,067,461.61 are hereby obligated to CLIN 0001, thereby increasing it from \$6,570,305,450.52 to \$6,571,372,912.13.

B. As a result of this modification, Part I - Schedule, Section B, Supplies or Services and Price/Cost, paragraph B, entitled "Obligation of Funds," is hereby revised to increase the total amount of funds obligated to the contract from \$7,970,024,927.38 to \$7,971,092,388.99.
