14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

A. The purpose of this modification is to de-obligate (Department of Energy (DOE)) funds from FD051100 and FD0513000 (Legacy B&Rs), an American Recovery and Reinvestment Act (ARRA) project, in accordance with SRNS Fin Plan No. 21 for FY 2015. Funds in the amount of (-\$1,253,542.56) are hereby de-obligated from CLIN 0003, thereby decreasing it from \$1,396,049,858.61 to \$1,394,796,316.05.

B. As a result of this modification, Part I - Schedule, Section B, Supplies or Services and Price/Cost, paragraph B, entitled "Obligation of Funds," is hereby revised to decrease the total amount of funds obligated to the contract from \$7,974,195,824.72 to \$7,972,942,282.16.
