


The purpose of this modification is to decrease funding currently obligated to the contract under the American Recovery and Reinvestment Act of 2009 Pub. L. 1115 (Recovery Act). This aligns the B&R with Environmental Management Funding Authorization.

Pursuant to Section I Contract Clause entitled "Obligation of Funds," funds in the amount of (\$100,000.00) are obligated for use in the EM Closure Activities and Contract Clause B-4 entitled "Obligation of Funds," is revised to show that the total amount of funds obligated under this contract since its inception is **decreased** from \$1,409,232,342.35 to \$1,409,132,342.35.
