

The purpose of this modification is to provide incremental funding and revise Section C, Statement of Work, as follows.

Pursuant to Section I Contract Clause entitled "Obligation of Funds," funds in the amount of \$108,253,660.88 are obligated for use in the Operation of SRS. As such, this Modification revises Contract Clause B-4 entitled "Obligation of Funds," to show that the total amount of funds obligated under this contract since its inception is \$938,846,620.29.

All other terms and conditions remain unchanged.
