

**14 DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible)**

A. The purpose of this modification is to de-obligate (Department of Energy (DOE)) funds from Legacy B&R FD530000, an American Recovery and Reinvestment Act (ARRA) project, in accordance with SRNS Fin Plan No. 25 for FY 2015. Funds in the amount of (-\$23,696.65) are hereby de-obligated from CLIN 0003, thereby decreasing it from \$1,394,178,608.57 to \$1,394,154,911.92.

B. As a result of this modification, Part I - Schedule, Section B, Supplies or Services and Price/Cost, paragraph B, entitled "Obligation of Funds," is hereby revised to decrease the total amount of funds obligated to the contract from \$7,989,711,438.71 to \$7,989,687,742.06.
