A. The purpose of this modification is to obligate funds to CLIN 0001, (Department of Energy (DOE)) in accordance with SRNS FINPLAN No. 1 for FY 2016. Funds in the amount of \$139,550,370.00 are hereby obligated to CLIN 0001, thereby increasing it from \$6,591,863,211.89 to \$6,731,431,581.89.

B. As a result of this modification, Part I - Schedule, Section B, Supplies or Services and Price/Cost, paragraph B, entitled "Obligation of Funds," is hereby revised to increase the total amount of funds obligated to the contract from \$7,989,687,742.06 to \$8,129,238,112.06.
