A. The purpose of this modification is to allot additional funding to CLIN 00005 in the amount of \$4,800,000.00. Funds are provided in accordance with Modification 063 for the procurement of Long Lead Items to support the Supplemental Salt Processing Initiative.

A.1. Funds in the amount of \$4,800,000.00 are hereby obligated to CLIN 00005, changing it **FROM:** \$17,943,509.00 **TO:** \$22,743,509.00.

B. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$4,800,000.00, changing it **FROM:** \$1,062,499,072.16 **TO:** \$1,067,299,072.16.
