A. The purpose of this modification is to definitize Modification 073 by the following equitable adjustment:

A.1. The estimated cost for work performed under Modification 073 from February 11, 2011 to March 28, 2011 is established at \$880,992.13 with the base fixed fee being \$48,454.57. The estimated cost for work performed under Modification 073 after March 28, 2011 is established at \$2,737,146.35 with an adjustment to the award fee pool of \$225,814.57. The total estimated cost of work under Modification 073 is \$3,618,138.48 plus a fee (fixed and award fee) of \$274,269.14 equals **\$3,892,407.62.**

B. The Contractor hereby releases the Government from any and all liability under this contract for further equitable adjustments attributable to such facts or circumstances giving rise to the modification (modification 087) as stated above.
