

A. The purpose of this modification is to definitize Modification 072 by the following equitable adjustment:

A.1. The estimated cost for work performed under Modification 072 is established at \$5,856,286.00 with an adjustment to the award fee pool of \$483,143.60. The total estimated cost of work of (\$5,856,286) plus the award fee (\$483,143.60) equals \$6,339,429.60.
