**SF30 Block 14**

A. The purpose of this modification is to allot additional funding to CLIN 00005 in the amount of **\$5,258,762.71**. Funds are provided in accordance with Modification 063 for the procurement of Long Lead Items to support the Supplemental Salt Processing Initiative.

A.I. Funds in the amount of **\$5,258,762.71** are hereby obligated to CLIN 00005, changing it **FROM: \$22,743,509.00 TO: \$28,002,271.71**.

B. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by **\$5,258,762.71**, changing it **FROM: \$1,067,299,072.16 TO: \$1,072,557,834.87**.

C. All other terms and conditions remain unchanged.
