A. The purpose of this modification is to allot additional funding in the amount of \$474,201.00 to CLIN 00001 for continued performance and to move funding in the amount of \$9,894,521.00 from CLIN 00005 to CLIN 00001.

A.1. Funds in the amount of \$474,201.00 are hereby obligated to CLIN 00001 changing it **FROM:** \$1,073,014,123.19 **TO:** \$1,073,488,324.19.

A.2 Funds in the amount of \$9,894,521.00 are hereby deobligated from CLIN 00005 and obligated to CLIN 00001 changing it **FROM:** \$1,073,488,324.19 **TO:** \$1,083,382,845.19.

B. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$474,201.00, changing it **FROM:** \$1,300,868,216.87 **TO:** \$1,301,342,417.87. The amount of \$1,301,342,417.87 is allocated as follows:
