
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

A. The purpose of this modification is to confirm parties negotiations of November 2, 2011 that the 10 Control Valve Actuators are no longer required and are deleted in there entirety from Modification 153.

The estimated cost of the Control Valve Actuators is \$100,286.00 with the base fixed fee being \$8,273.00. This modification hereby reduces Modification 153 by \$108,559.00.
