A. The purpose of this modification is to establish a ceiling amount to conduct an alternatives analysis for the storage of vitrified glass. This analysis is authorized a Not-To-Exceed amount of \$25,000.00. Costs incurred for this project shall be charged to funding obligated to CLIN 00001 under WBS 01.90.0.01.04 Defense Waste Processing Facility and Saltstone Engineering Services.

B. Due date of the alternatives analysis is December 22, 2011. At a minimum the alternatives evaluated should include the currently planned glass waste storage building (with an option to increase storage to accommodate all forecast canisters), above ground cask storage, and contracting options for storage (such as privatization).
