A. A. The purpose of this modification is to definitize Modification 122 by the following equitable adjustment:

The total estimated cost for work performed under Modification 122 is established at \$5,980,305.00 plus an award fee of \$458,324.00 and a fixed fee of \$22,647.00. The total estimated cost of work under Modification 122 equals \$6,461,276.00.

B. In consideration of the modification (Mod 159) agreed to herein as complete equitable adjustment for the Contractor's "proposals for adjustment" under SRR letter SRR-CAA-2011-00492, the Contractor hereby releases the Government from any and all liability under this contract for further equitable adjustments attributable to such facts or circumstances giving rise to the "proposals for adjustment."
