

A. The purpose of this modification is to obligate funding in the amount of \$34,500,000.00 to CLIN 00001.

A.1. Funds in the amount of \$34,500,000.00 are hereby obligated to CLIN 00001 changing it FROM: \$1,228,145,009.61 TO: \$1,262,645,009.61.

B.
