


SF30 Block 14

A. The purpose of this modification is to:

- (1) Incorporate the additional effort required for the contractor to achieve the incremental regulatory requirements imposed on tank closure as directed by the Contracting Officer in letter # WDPD-12-08, and letter # WDPD-12-18; and
- (2) Adjust the contract estimated cost based on Savannah River Remediation's Cost Proposal # CAA-CP-2012-003, dated June 8, 2012, entitled "Tank Closure Additional Effort Proposal" pursuant to contract clause I.78 'Limitation of Funds' (FAR 52.232-22).

B. To recognize the cost impact, the contract's total estimated cost is changed as follows:

- (1) Basic Term: \$6,547,812.00
- (2) Option 1: \$3,201,835.00

The total estimated contract cost without options is increased by \$6,547,812.00, changing it **FROM** \$2,932,413,685.95 **TO** \$2,938,961,497.95.

The total estimated contract cost with options is increased by \$9,749,647.00, changing it **FROM** \$3,843,109,667.65 **TO** \$3,852,859,314.65.

- C. Implementation of these regulatory requirements will necessitate a Baseline Change Proposal (BCP) to ensure project control. The BCP will be processed in accordance with contract clause H.14.
- D. All other terms and conditions remain unchanged.
