**SF30 Block 14**

- A. The purpose of this modification is to obligate funding in the amount of \$98,000,000.00 to CLIN 00001.
- B. Funds in the amount of \$98,000,000.00 are hereby obligated to CLIN 00001, changing it from \$1,697,144,517.42 to \$1,795,144,517.42.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$98,000,000.00, changing it from \$1,915,104,090.10 to \$2,013,104,090.10.
