

- A. The purpose of this modification is to de-obligate funding in the amount of \$166,991.27 from CLIN 00004.
- B. Funds in the amount of \$166,991.27 are hereby de-obligated from CLIN 00004, changing it from \$199,851,821.97 to \$199,684,830.70.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to decrease the total amount of funds obligated to the contract by \$166,991.27, changing it from \$2,024,334,090.10 to \$2,024,167,098.83. The amount of \$2,024,167,098.83 is allocated as follows:
