- A. The purpose of this modification is to de-obligate funding in the amount of \$19,841,659.92 from CLIN 00001.
- B. Funds in the amount of \$19,841,659.92 are hereby de-obligated from CLIN 00001, changing it from \$1,806,374,517.42 to \$1,786,532,857.50.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to decrease the total amount of funds obligated to the contract by \$19,841,659.92, changing it from \$2,024,167,098.83 to \$2,004,325,438.91. The amount of \$2,004,325,438.91 is allocated as follows:
 - CLIN 00001 \$1,786,532,857.50
 - CLIN 00004 \$199,684,830.70
 - CLIN 00005 \$18,107,750.71
- D. All other terms and conditions remain unchanged.
