- A. The purpose of this modification is to obligate funding in the amount of \$15,700,000 to CLIN 00001.
- B. Funds in the amount of \$15,700,000 are hereby obligated to CLIN 00001, changing it from \$1,806,374,517.42 to \$1,822,074,517.42.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$15,700,000, changing it from \$2,024,167,098.83 to \$2,039,867,098.83. The amount of \$2,039,867,098.83 is allocated as follows:

CLIN 00001 \$1,822,074,517.42

CLIN 00004 \$199,684,830.70

CLIN 00005 \$18,107,750.71
