

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

A. The purpose of this modification is to establish a maximum funding amount for Salt Solution Receipt Tanks (SSRT) Chemical Hazards Controls Implementation.
