

- A. The purpose of this modification is to obligate funding in the amount of \$3,120,000 to CLIN 00001.
- B. Funds in the amount of \$3,120,000 are hereby obligated to CLIN 00001, changing it from \$2,039,074,517.42 to \$2,042,194,517.42
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$3,120,000, changing it from \$2,256,867,098.83 to \$2,259,987,098.83. The amount of \$ \$2,259,987,098.83 is allocated as follows:
 - CLIN 00001 \$2,042,194,517.42
 - CLIN 00004 \$199,684,830.70
 - CLIN 00005 \$18,107,750.71
- D. All other terms and conditions remain unchanged.
