- A. The purpose of this modification is to obligate funding in the amount of \$3,500,000.00 to CLIN 00001.
- B. Funds in the amount of \$3,500,000.00 are hereby obligated to CLIN 00001, changing it from \$2,042,448,657.42 to \$2,045,948,657.42.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$3,500,000.00, changing it from \$2,260,241,238.83 to \$2,263,741,238.83. The amount of \$2,263,741,238.83 is allocated as follows:
 - CLIN 00001 \$2,045,948,657.42
 - CLIN 00004 \$199,684,830.70
 - CLIN 00005 \$18,107,750.71
