- A. The purpose of this modification is to obligate funding in the amount of \$4,028,718.03 to CLIN 00001.
- B. Funds in the amount of \$4,028,718.03 are hereby obligated to CLIN 00001, changing it from \$2,044,262,817.32 to \$2,048,291,535.35.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$4,028,718.03, changing it from \$2,262,055,398.73 to \$2,266,084,116.76. The amount of \$2,266,084,116.76 is allocated as follows:

  - CLIN 00004 \$199,684,830.70
