- A. The purpose of this modification is to obligate funding in the amount of \$103,942,000.00 to CLIN 00001.
- B. Funds in the amount of \$103,942,000.00 are hereby obligated to CLIN 00001, changing it from \$2,048,888,382.24 to \$2,152,830,382.24.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$103,942,000.00, changing it from \$2,266,680,963.65 to \$2,370,622,963.65. The amount of \$2,370,622,963.65 is allocated as follows:
