- A. The purpose of this modification is to obligate funding in the amount of \$1,334,118.00 to CLIN 00001 for support of the Salt Waste Processing Facility (C.1.3.4).
- B. Funds in the amount of \$1,334,118.00 are hereby obligated to CLIN 00001, changing it from \$2,161,301,311.24 to \$2,162,635,429.24.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$1,334,118.00, changing it from \$2,379,093,892.65 to \$2,380,428,010.65. The amount of \$2,380,428,010.65 is allocated as follows:
