- B. Funds in the amount of \$55,000,000.00 are hereby obligated to CLIN 00001, changing it from \$2,162,655,429.24 to \$2,217,655,429.24.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$55,000,000.00, changing it from \$2,380,448,010.65 to \$2,435,448,010.65. The amount of \$2,435,448,010.65 is allocated as follows:
