

**SF30 Block 14**

- A. The purpose of this modification is to obligate funding in the amount of \$38,120,000.00 to CLIN 00001.
- B. Funds in the amount of \$38,120,000.00 are hereby obligated to CLIN 00001, changing it from \$2,217,655,429.24 to \$2,255,775,429.24.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$38,120,000.00, changing it from \$2,435,448,010.65 to \$2,473,568,010.65. The amount of \$2,473,568,010.65 is allocated as follows:
  - CLIN 00001 \$2,255,775,429.24
  - CLIN 00004 \$199,684,830.70
  - CLIN 00005 \$18,107,750.71
- D. All other terms and conditions remain unchanged.
