As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$35,000,000.00, changing it from \$2,473,568,010.65 to \$2,508,568,010.65.
