

- A. The purpose of this modification is to obligate funding in the amount of \$6,746,158.56 to CLIN 00001.
- B. Funds in the amount of \$6,746,158.56 are hereby obligated to CLIN 00001, changing it from \$2,621,330,570.71 to \$2,628,076,729.27.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$6,746,158.56, changing it from \$2,839,123,152.12 to \$2,845,869,310.68. The amount of \$2,845,869,310.68 is allocated as follows:
