- A. The purpose of this modification is to obligate funds in the amount of \$36,000,000.00 to CLIN 0001.
- B. Funds in the amount of \$36,000,000.00 are hereby obligated to CLIN 00001, changing it from \$2,630,109,358.31 to \$2,666,109,358.31.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$36,000,000.00, changing it from \$2,852,833,939.72 to \$2,888,833,939.72. The amount of \$2,888,833,939.72 is allocated as follows:
