- A. The purpose of this modification is to obligate funds in the amount of \$94,000,000.00 to CLIN 0001.
- B. Funds in the amount of \$94,000,000.00 are hereby obligated to CLIN 00001, increasing it from \$2,702,109,358.31 to \$2,796,109,358.31.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$94,000,000.00, changing it **FROM:** \$2,939,935,939.72 **TO:** \$3,033,935,939.72.
