

- A. The purpose of this modification is to obligate funds in the amount of \$7,500,000.00 to CLIN 0006 for the construction of Saltstone Disposal Unit (SDU) 6.
- B. Funds in the amount of \$7,500,000.00 are hereby obligated to CLIN 00006, increasing it from \$20,034,000.00 to \$27,534,000.00.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$7,500,000.00, changing it **FROM:** \$3,035,935,939.72 **TO:** \$3,043,435,939.72. The amount of \$3,043,435,939.72 is allocated as follows:
