- A. The purpose of this modification is to deobligate funds in the amount of \$42,034,655.07 from CLIN 0001.
- B. Funds in the amount of \$42,034,655.07 are hereby deobligated from CLIN 0001, decreasing it from \$2,798,109,358.31 to \$2,756,074,703.24.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to decrease the total amount of funds obligated to the contract by \$42,034,655.07, changing it **FROM:** \$3,137,981,153.72 **TO:** \$3,095,946,498.65. The amount of \$3,095,946,498.65 is allocated as follows:

CLIN 00002 \$94,545,214.00

CLIN 00004 \$199,684,830.70
