- A. The purpose of this modification is to deobligate funds in the amount of \$5,199,583.14 from CLIN 0002.
- B. Funds in the amount of \$5,199,583.14 are hereby deobligated from CLIN 0002, decreasing it from \$127,450,432.03 to \$122,250,848.89.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to decrease the total amount of funds obligated to the contract by \$5,199,583.14, changing it **FROM:** \$3,141,491,653.72 **TO:** 3,136,292,070.58. The amount of \$3,136,292,070.58 is allocated as follows:
