- A. The purpose of this modification is to obligate funds in the amount of \$506,831.95 to CLIN 0002 for the support of the Salt Waste Processing Facility (C.1.3.4).
- B. Funds in the amount of \$506,831.95 are hereby obligated to CLIN 0002, increasing it from \$127,450,432.03 to \$127,957,263.98.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$506,831.95, changing it **FROM:** 3,141,491,653.72 **TO:** 3,141,998,485.67.
