- A. The purpose of this modification is to obligate funds in the amount of \$57,387.00 to CLIN 0002 for the DOE-Office of River Protection (ORP) Waste Management Area C Performance Assessment.
- B. Funds in the amount of \$57,387.00 are hereby obligated to CLIN 0002, increasing it from \$321,365,229.08 to \$321,422,616.08
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$57,387.00, changing it **FROM:** \$3,347,304,620.77 **TO:** \$3,347,362,007.77. The amount of \$3,347,304,620.77 is allocated as follows:
  - CLIN 00001 \$2,766,248,640.28
  - CLIN 00002 \$321,422,616.08
  - CLIN 00004 \$199,684,830.70
