- A. The purpose of this modification is to obligate funds in the amount of \$56,000,000.00 to CLIN 0002 and to obligate funds in the amount of \$14,235,754.00 to CLIN 0006 for SDU6 construction activities.
- B. Funds in the amount of \$56,000,000.00 are hereby obligated to CLIN 0002, increasing it from \$395,665,791.08 to \$451,665,791.08.
- C. Funds in the amount of \$14,235,754.00 are hereby obligated to CLIN 0006, increasing it from \$50,406,246.00 to \$64,642,000.00.
- D. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$70,235,754.00, changing it **FROM:** \$3,430,113,258.77 **TO:** \$3,500,349,012.77.
