- A. The purpose of this modification is to obligate funding in the amount of \$75,827,177.00 to CLIN 00001.
- B. Funds in the amount of \$75,827,177.00 are hereby obligated to CLIN 00001, changing it from \$2,468,783,552.27 to \$2,544,610,729.27.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$75,827,177.00, changing it from \$2,686,576,133.68 to \$2,762,403,310.68. The amount of \$2,762,403,310.68 is allocated as follows:
 - CLIN 00001 \$2,544,610,729.27
 - CLIN 00004 \$199,684,830.70
 - CLIN 00005 \$18,107,750.71
- D. All other terms and conditions remain unchanged.
