- A. The purpose of this modification is to obligate funding in the amount of \$26,000,000.00 to CLIN 00001.
- B. Funds in the amount of \$26,000,000.00 are hereby obligated to CLIN 00001, changing it from \$2,293,125,429.24 to \$2,319,125,429.24.
- C.
