- A. The purpose of this modification is to obligate funding in the amount of \$1,334,119.22 to CLIN 00001.
- B. Funds in the amount of \$1,334,119.22 are hereby obligated to CLIN 00001, changing it from \$2,467,449,433.05 to \$2,468,783,552.27.
- C. As a result of this modification, Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$1,334,119.22, changing it from \$2,685,242,014.46 to \$2,686,576,133.68. The amount of \$2,686,576,133.68 is allocated as follows:
