- A. The purpose of this modification is to obligate funds in the amount of \$20,043,978.00 to CLIN 0002.
- B. Funds in the amount of \$20,043,978.00 are hereby obligated to CLIN 0002, increasing it from \$809,998,308.09 to \$830,042,286.09.
- C. Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to increase the total amount of funds obligated to the contract by \$20,043,978.00, changing it **FROM:** \$3,864,231,242.92 **TO:** \$3,884,275,220.92.
