- B. Funds in the amount of \$924,000.00 are hereby deobligated from CLIN 0002, decreasing it from \$830,042,286.09 to \$829,118,286.09.
- C. Part I – The Schedule, Section B, Supplies or Services and Prices/Costs, Paragraph B.4 entitled “Limitation of Funds” is hereby revised to decrease the total amount of funds obligated to the contract by \$924,000.00, changing it **FROM:** \$3,884,275,220.92 **TO:** \$3,883,351,220.92.
